


Drain Pan Installation Instructions For Models: VP23, VP25, VP27, VP31

Tough Pans Pro Series are manufactured for use with all electric and gas water heaters. This product has been approved by the ICC to be in compliance with the IPC, UPC, IRC and NSPC.

Caution: to ensure proper performance of product, instructions must be followed.

- 1. Inspect the drain pan for any shipping damage that may have occurred. If cracked or broken, DO NOT USE.
- 2. Attach Fitting remove zinc nut leave the rubber washer on the fitting push the threads through the outside of the pan to the inside of the pan attach the zinc nut to the fitting inside the pan tighten to slightly compress the rubber washer DO NOT OVER TIGHTEN



- Make sure the pan-mounting surface is level and free of any and all debris.
- 4. Place the water tank inside the pan.
- 5. When brazing plumbing, take precautions to prevent pan from coming in contact with torch heat or brazing materials.
- 6. Plumb drain pan, if required, In accordance with local applicable codes.


Drain Pan Installation Instructions For Models: VP23R, VP25R, VP27R

Tough Pans Dry Lift are manufactured for use with all electric, or gas water heater tanks without legs and rated zero clearance by the manufacturer.


